## VOTE YES ON THE DEPARTMENT OF EARLY CHILDHOOD ACT

SB1 (Lightford) / HB 5451 (Canty)

The proposal unites State early childhood services into one new agency – the Department of Early Childhood.

Uniting early childhood services in Illinois can make access to services <u>simpler</u>, <u>better</u>, and <u>fairer</u> for families with young children and make more <u>efficient use of state resources</u>. Currently, most early childhood programs are split across three state agencies.

#### THE DEPARTMENT OF EARLY CHILDHOOD ACT:

- Creates the Department of Early Childhood effective 7/1/24.
- Transfers statutory authority to administer early childhood programs from ISBE, DHS, & DCFS to the new Department of Early Childhood beginning 7/1/26.
- Requires the new Department of Early Childhood to designate a body by 7/1/26 to advise the Department on an ongoing basis, ensuring it functions transparently, operates with a commitment to racial equity, and devotes attention to data collection and timely public reporting.

change early
childhood
programs or
service delivery.

### WHAT IS THE TIMELINE FOR CHANGES?

All early childhood programs will continue to be administered by the legacy agencies through June of 2026. Until then, the Department of Early Childhood will build internal capacity and work with providers, parents, educators, and other stakeholders to reimagine early learning programs. The new agency will begin administering early learning programs in FY27 (July 1, 2026).

Establishing the Department of Early Childhood will **advance the goals of Smart Start Illinois**, making it easier for families to access services, and reduce the administrative burdens placed on providers.

# VOTE YES ON THE DEPARTMENT OF EARLY CHILDHOOD ACT

SB 1 (Lightford) / HB 5451 (Canty)

Illinois' early childhood system is **too siloed** and complex—there is a simpler, better structure for parents and families and for early learning providers.

Ultimately, providers and families bear too much of the burden in navigating the complexity, which results in greater inefficiency. Inefficiency advances inequity in the system by not allowing the state to target resources and programs to areas with service gaps. Unifying programs under the Department of Early Childhood will help address these challenges.
